

Cases involve ejectment (wrongful occupation of lands, squatters), patent fraud, import impoundment, promissory notes, water lots in San Francisco, unpaid taxes and unpaid moneys, lands in Oakland (Kellersburger map), San Mateo (Rancho de las Pulgas), Santa Clara (Guadalupe Mines), John C Fremont, Pacific Mail Steamship Company, trips across the Isthmus of Panama, Gustave Touchard, and more. These cases are very local and tell great stories of California in its early statehood.
